Subj: OPERATION OF COFFEE MESSES

Ref: (a) MCO 5760.4B

1. Purpose. To provide instruction for establishment of all coffee messes aboard Marine Corps Air Station, Yuma.

2. Cancellation. StaO 4061.3C

3. Background. The reference identifies a coffee mess as an unofficial activity of limited scope and therefore excludes them from the regulations concerning private organizations. The intent of this Order is to ensure that coffee messes do not operate in competition with Morale, Welfare and Recreation revenue generating (i.e. Marine Corps Exchange or Clubs) activities. The funds obtained from these revenue generators provide operating capital to the Recreation Fund. That is the prime consideration in limiting coffee mess activities.

4. Action. All coffee messes will operate as prescribed by the reference, and will not sell or solicit funds for the purpose to sell any food stuffs to include candy in connection with their operations. The only beverages authorized for sale by an authorized coffee mess are coffee, tea, hot chocolate, sugar, and dairy/non-dairy creamer. Coffee messes are not authorized to engage in the resale of food or other merchandise.

a. Each activity/unit/shop desiring to operate a coffee mess must first obtain prior authorization from the Station Fire Inspector's office. Upon approval from the Station Fire Inspector, all requests for authorization will be directed to the Commanding Officer via the MWR Director.

b. All coffee messes which operate without approval or outside the parameters of the Order will be subject to administrative action.

c. Commanding Officers and department heads will ensure that coffee messes are authorized and operate according to this Order.
